Greetings Director-General Dr. Tedros Adhanom Ghebreyesus or Successors and Assigns,


On behalf of The New Jersey Assembly, who holds superior, concurrent, general jurisdiction, I am writing to formally notify the World Health Organization (WHO) of our decision to withdraw from membership or any obligations in the organization, effective immediately.

This order from The New Jersey Assembly is protected by the Federal Constitutions, Articles of Confederation, Treaties, Foreign Sovereignty Immunities Act, and Law of Peace. Any of your pandemic emergency, acts, declarations, statements or actions are not lawful on the land and soil on New Jersey and are wholly rejected by the people on New Jersey. All infringements are considered as an act of terrorism.

We request confirmation that New Jersey will no longer be subject to WHO resolutions, recommendations, or obligations following the effective date of our withdrawal. We also ask that all data and records pertaining to The New Jersey Assembly and the people on New Jersey

held by the WHO be handled in accordance with international law and data protection standards.

Please direct all correspondence regarding this matter to Tammy Ann Healy, Acting Head of State. We look forward to your acknowledgment of this letter and further details on the withdrawal process within 30 days.


