We wish to take this opportunity to introduce ourselves as The New Jersey Assembly; men and women standing as "we the people" of the original Land and soil Jurisdiction of New Jersey. We represent New Jersey State, the unincorporated State of the Union; a member of the Federation of States, (*The United States of America, unincorporated.*) We are the original Lawful Governance Structure on New Jersey that established New Jersey as a state, and we hold superior, concurrent General Jurisdiction.

We live by the clear and simple divine percepts of; do no harm, be in honor, act in kindness, and leave things better than you found them. We affirm that we are at peace and will keep the peace and uphold the Public Law for the people. We extend our honor and our hands in friendship and peace to the County Sheriffs on New Jersey.

The jurisdiction that you operate in is a commercial, maritime, administrative jurisdiction that is contracted by the Territorial and/or Municipal Constitution. Your jurisdiction is incorporated and a commercial business entity. It was established to work with only Corporations not the living people on your State or County. This is where the jurisdictional boundaries are to be observed and respected.

The Authority Pyramid of the actual American State:

County Sheriff (Land- Peacekeeper-Public)

State Marshal-at-Arms (Land-Peacekeeper-Public)

State Militia Commander (Land-Peacekeeper-Public)

State Trooper or Rangers (Land- Peacekeeper-Public)

Law Enforcement Officer – Police Officers,

“COUNTY OF SHERIFFS” (Law Enforcement – Commercial)

Private Detectives, Bailiffs, etc. (Can be State or State of State)

And on the Federal (International) side:

Federal, also known as **Continental, Marshals** (Peacekeeper – Public)

U.S. Marshals (Law Enforcement – Commercial)

Agency Personnel (Law Enforcement – Commercial)

Provost Marshal (Should be a Peacekeeping Officer, but isn't currently.)

This may come as a surprise. There is much literature from other governmental agencies that obfuscate and indoctrinate you and your departments in not recognizing the boundaries. “Sovereign Citizen” is one such term.

Recently, Supreme Court Judge Neil Gorsuch, stated that in the United States, we are all sovereign. As far as "citizen" its' definition is someone who works for a government or in our jurisdiction, someone who works for the people. The New Jersey Assembly recognizes that as a County Sheriff operating on the land and soil jurisdiction on New Jersey that:

- (1) You are the highest Peacekeeping and Law Enforcement Officer within the County borders;
- (2) You are indemnified and hold state immunity;
- (3) You directly outrank all Federal Personnel and Agency Employees;
- (4) You directly outrank all State of State and State Trust Employees;
- (5) You are empowered and required to protect the people on your county and their assets;
- (6) You may deputize as many Americans as you deem necessary;
- (7) You are advised that there are no Federal Eminent Domain rights;
- (8) If a properly constituted State Legislature acting prior to 1860 has not specifically granted land to a Federal entity for public purposes, Federal Personnel making claims to own or control land within your County are guilty of international trespass, false claims, and conspiracy to defraud under color of law;
- (9) Any Federal Personnel offering to encumber, delay or restrict civilian rescue and recovery efforts must be arrested; any Federal Personnel confiscating disaster relief supplies must be arrested;

New Jersey is an American republican nation-state unto itself. We are the employers of the Federal Service contractors who were employed, through service contracts called Constitutions, to provide supportive services for the unified nation-states; who instead usurped our power, national sovereignty, identity, and assets during the "American Civil War", and continue to unlawfully wield undelegated authority against the people today. For decades, we have been living under a corporatocracy and a technocracy implemented by the globalist "elite" (i.e. central banks, IMF, UN, WEF, WHO) and other unelected international corporate employees and entities that control governments, bribe politicians, influence policies, enslave the people, and who are now acting in clear criminal trespass.

On October 1, 2024, The voluntary Chapter 7 Bankruptcy for the Municipal Corporation, United States Inc. is finalized and the foreign for-profit corporation liquidated as of 1pm Eastern Standard Time. This includes any STATE OF NEW JERSEY corporate entity (DUNS # 067373258- review the franchise here: https://www.dnb.com/business-directory/company-profiles.state_of_new_jersey.be33b0b4907fa6be5eb4c3a64dd4126c.html) and its subsidiaries, franchises and branches. They are unauthorized to operate within New Jersey State.

As of October 5, 2024 Land Law has been declared in all 50 Union States, known as The United States. Each State is geographically defined, and has actual and factual entities with borders, and physical assets.

The Military, which was previously a commercial mercenary corporation, has been lawfully converted back to an honorable soldiery as of October 5, 2024. This applies to all Federal and State of New Jersey, New Jersey Trust and county elected officials and hired officers.

The people on New Jersey require that men and women who hold the Office of Sheriff be of integrity and honor, uphold the Public Law, and protect the living people and their property. Until your decision is known however, please be advised that we, The New Jersey Assembly, hold superior concurrent General Jurisdiction, and may call upon your Office when and if needed to stand in alliance with us. We look forward to updating our records accordingly, and if it's your intention to be a Lawful Land and soil Sheriff for the people, upon your notification as such, we will be in touch to assist with the process.






